**SUBJECT: Invitation of Expression of Interest (EOI) for Empanelment of Agencies / Procurement Centres for Procurement of Wheat under MSP Operations during Rabi Marketing Season (RMS) 2026–27**

## 1. Background

In pursuance of the directions of the Competent Authority and in accordance with the guidelines issued by the Government of India for procurement of Wheat under Minimum Support Price (MSP) during RMS 2026–27, NCCF Kanpur Branch proposes to empanel eligible agencies for facilitating procurement operations within its assigned jurisdiction in Uttar Pradesh.

## 2. Invitation

Sealed Expressions of Interest (EOI) are hereby invited from eligible Farmer Producer Organizations (FPOs), Primary Agricultural Cooperative Societies (PACS), Cooperative Societies, and other eligible procurement agencies for empanelment as Procurement Centres / Facilitating Agencies for Wheat procurement under MSP operations.

## 3. Scope of Work

The empanelled agency shall be responsible for:

- Procurement of FAQ grade Wheat strictly as per Government of India norms.
- Verification of farmers and ensuring procurement through designated Government portal.
- Arrangement of calibrated electronic weighment facilities.
- Quality testing (moisture content, foreign matter, etc.) as per prescribed standards.
- Maintenance of complete procurement documentation and daily reporting to NCCF.
- Coordination for safe storage and delivery at designated warehouses (CWC/SWC/approved godowns).
- Ensuring compliance with MSP guidelines and statutory provisions.

## 4. Eligibility Criteria

The applicant must:

- Be duly registered under the relevant Act.

2. Possess valid PAN and GST registration (if applicable).
3. Have adequate infrastructure including weighing scale, moisture meter, manpower, and operational facilities.
4. Maintain an operational bank account in the name of the organization.
5. Submit an affidavit/undertaking confirming that the agency has not been blacklisted by any Government Department/PSU.

## **5. Security Deposit / Bank Guarantee**

The selected agency shall be required to furnish a **Security Deposit of ₹10,00,000/- (Rupees Ten Lakhs only)** prior to commencement of procurement operations.

The Security Deposit shall be submitted in the form of:

- Demand Draft, or
- RTGS, or
- **Irrevocable and Unconditional Bank Guarantee** issued by a Scheduled Commercial Bank in favour of NCCF, Kanpur Branch.

### **Conditions:**

- a. No interest shall be payable on the Security Deposit.
- b. The Security Deposit shall be liable to forfeiture in case of breach of terms, non-performance, financial irregularity, or deviation from MSP guidelines.
- c. Refund shall be subject to satisfactory completion of procurement operations and clearance of all dues.

## **6. Documents to be Submitted**

The applicant shall submit self-attested copies of:

1. Registration Certificate
2. PAN Card
3. GST Registration Certificate (if applicable)
4. Bank Account Details (Cancelled Cheque)
5. Infrastructure Details
6. Experience Details (if any)
7. Non-Blacklisting Affidavit
8. Authorization Letter of Signatory

Incomplete applications shall be rejected summarily.

## **7. Selection Procedure**

- i. Applications shall be opened and scrutinized by the Branch Level Committee.
- ii. Comparative assessment statement shall be prepared.
- iii. Physical verification may be conducted, if required.
- iv. Empanelment shall be subject to approval of the Competent Authority.
- v. NCCF reserves the right to accept or reject any or all applications without assigning any reason thereof.

## 8. Validity of Empanelment

The empanelment shall remain valid for RMS 2026–27 or until completion of procurement operations, whichever is earlier.
