

SHORT TENDER NOTICE:**For Supply of White Colour Single Boiled Rice to The Puducherry State Cooperative Consumers' Federation Ltd. (CONFED)**

The National Cooperative Consumers' Federation of India Ltd. (NCCF) Bangalore Branch, invites **sealed quotations from its empanelled suppliers** for the **back-end supply of White Colour Single Boiled Rice** (varieties: ADT-36, ADT-38, ADT-39, ADT-43, ADT-45, IR-50, IR-20, SORNA), in response to the e-tender floated by **The Puducherry State Cooperative Consumers' Federation Ltd. (CONFED)**, vide tender Ref. No. PSCCF/C/Rice/PDS/1701/2025 dated 13.06.2025.

The scope of work includes the supply and doorstep delivery of White Colour Single single-boiled rice as per CONFED specifications. The total indicative quantity is **46,350 MT**, subject to allocation by CONFED. The supply period will extend from **August 2025 to April 2026**, and the rice should be packed in **10 kg multi-colour BOPP laminated PP woven bags with a handle**, conforming to FSSAI and CONFED labelling norms. The rice must be delivered to **475 Fair Price Shops** across **Puducherry (385 shops)** and **Karaikal (90 shops)** or any other delivery point as specified by CONFED.

The rate to be quoted should be per kilogram and must be inclusive of all associated costs, including packing, handling, transport to FPS doorsteps, all applicable taxes, duties, cess, transit insurance, unloading, labour, and local delivery charges.

As per CONFED tender requirements, a **non-refundable Tender Application Fee of ₹5,000/-** and an **Earnest Money Deposit (EMD) of ₹5,00,00,000/- (Rupees Five Crores Only)** are applicable. The selected back-end supplier must submit the EMD to NCCF through RTGS/NEFT. The payment shall be made in favour of:

Interested empanelled suppliers are also required to submit **three (3) sealed samples** of 1 kg each of the proposed rice variety to the NCCF Bangalore Branch Office. Each sample should be clearly labelled with the variety name. These samples will be forwarded to CONFED for quality verification and will serve as the reference standard for supply during the contract period.

Along with the quotation, the suppliers must submit their all-inclusive per kg rate and a declaration confirming adherence to CONFED specifications. The **last date for submission of sealed quotations along with samples is 11th July 2025 10 A.M.**


