1	Annexure-D – List of Food Items, Sl. No. 7, Page No. 17 (Specifications – Sunflower Oil)	The approved brands for edible oil were specified as Fortune, Gold Winner, Freedom and Gold Drop.	Vijaya Brand Edible Oil, manufactured by Andhra Pradesh Dairy Development Cooperative Federation (APDDCF), is hereby included as an approved brand under Sl. No. 7 of Annexure-D. The supply of edible oil shall conform to all prescribed quality standards and specifications stipulated in the EOI.
2	Section 2, Point No. 13, Page No. 5	Bidders were required to submit valid FSSAI, AGMARK, and ISO Certificates (ISO 9001 & ISO 22000) as part of the eligibility criteria.	AGMARK and ISO Certificates shall not be required as part of the bidder eligibility criteria. However, all food items and provisions which the successful bidder would supply shall be supported by valid AGMARK and relevant ISO Certificates, wherever applicable, throughout the contract period.

All other terms and conditions of the original EOI shall remain unchanged.

This corrigendum shall form an integral part of the original EOI document and shall be read in conjunction with the same.
